## ITEM #6 Presentations

A). Dennis Larios-Milton Sewer Extension

Dennis Larios of Brinnier and Larios Engineers in Kingston said they have done the engineering for the original Milton Sewer District and the Marlboro Sewer District. He presented a Map, Plan and Report (MP&R) for two property owners, 2 parcels for Dean-Paul Properties and 1 parcel for Young's Motors. The sewer district extension will be Town funded and managed and the Town will collect payments from the property owners as outlined in the MP&R. The map shows where the extension district will be and there is a survey description. The plan shows how the public sewer can be extended. The report explains the costs in more detail than in the feasibility study that was done in April. The report also gives an outline of a capital cost repayment schedule for a 20 year, 5% interest decreasing payment but there are other bond options available and the interest rate would likely be lower. In the MP&R he outlined how much it would cost each property owner annually for capital costs, parent district tax payment based on the tax rate for the district, and operating and maintenance costs based on the user charge. The operation and maintenance estimate is high but it also depends on what type of business(s) Dean Paul Properties construct on their currently vacant property. The capacity analysis is also included in the report as well as the outline for the four properties that the Town has out of district user agreements with. Once the Town goes through the public hearing process then the Town will apply to the State Comptroller for approval of the district extension. The Comptroller looks at safeguarding the finances of the Town and the ability of the properties to absorb the debt.

A few of the Board members discussed some of the construction details with Mr. Larios. Mr. Larios explained that the estimate for the project increased from the last meeting because it was decided that it would be publicly financed which creates more costs. Some of the Board members discussed the next steps involved in the process. Supervisor Osborn allowed questions for Mr. Larios from the public at this time.

#### B). Tabor Place

Supervisor Osborn presented a map showing Tabor Place. The developer subdivided in the mid nineties and the road way was proposed but only a portion was accepted as a Town road. The developer is no longer around and the four residents who live on the unaccepted portion of the road would like it to be a Town road.

The majority of the Board discussed the options with the residents of Tabor Place who were present at the meeting for making the remaining portion of Tabor Place a Town road. The road can be privately paved and paid for by the owners as long as it is brought up to spec according to Town Code or the Highway Superintendant can get a price to pave the

road to spec and the Town can get a figure on what it would cost to bond through the Town for 30 years and tax the four residents over that time period.

Mark Reynolds asked if voting no on the Marwest settlement resolution at the last meeting was an issue.

Kate Beare announced that the Bounty Festival is Saturday, October 3, 2015 from 10 .a.m.-4:00 p.m. She asked the Town Board for permission to place an 80 x 40 inflatable play structure near the soccer field where it will likely overlap because of its size. If the Bounty Festival is on Sunday (rain date) they won't have this inflatable because there will be soccer.

The Board said yes as long as it is safe and there is no soccer.
