

NOTICE OF SPECIAL ELECTION

MARLBOROUGH FIRE DISTRICT,

NOTICE IS HEREBY GIVEN that a Special Election of the qualified voters of the Marlborough Fire District (hereinafter called the "Fire District"), in the Town of Marlboro, Ulster County, New York, will be held at the firehouse located at 14 Grand Street, Marlboro, New York, in said Fire District, on Tuesday, October 24, 2017. The polls shall open at 6:00 o'clock P.M. (Prevailing Time) and shall remain open until 9:00 o'clock P.M. (Prevailing Time) or as much longer as may be necessary to enable the voters then present to cast their votes.

NOTICE IS HEREBY FURTHER GIVEN that pursuant to the resolution adopted by the Board of Fire Commissioners of the Fire District on September 12, 2017, the following Proposition will be submitted to the qualified voters of the Fire District for approval or disapproval:

PROPOSITION

SHALL the bond resolution of Marlborough Fire District, in the Town of Marlboro, New York, entitled: "BOND RESOLUTION OF THE MARLBOROUGH FIRE DISTRICT ("FIRE DISTRICT"), IN THE TOWN OF MARLBORO, ULSTER COUNTY, NEW YORK, ADOPTED SEPTEMBER 12, 2017, AUTHORIZING, FOR USE BY THE FIRE DISTRICT, THE PURCHASE OF A RESCUE PUMPER FIRETRUCK, INCLUDING APPARATUS AND EQUIPMENT USED IN CONNECTION THEREWITH; STATING THE ESTIMATED MAXIMUM COST THEREOF IS NOT TO EXCEED \$795,000; APPROPRIATING SAID AMOUNT FOR SUCH PURPOSE, INCLUDING THE APPROPRIATION OF THE AMOUNT OF NOT TO EXCEED \$145,000, HEREBY AUTHORIZED TO BE EXPENDED FROM THE EXISTING "CAPITAL RESERVE FUND FOR FIRE FIGHTING EQUIPMENT, VEHICLES AND APPARATUS AND EQUIPMENT APPURTENANT THERETO" HERETOFORE ESTABLISHED, TO BE APPLIED TOWARD THE COST THEREOF AND THE ISSUANCE OF NOT TO EXCEED \$650,000 SERIAL BONDS TO FINANCE THE BALANCE OF SAID APPROPRIATION;

DETERMINING THAT THE PERIOD OF PROBABLE USEFULNESS OF SAID FIRE TRUCK IS TWENTY (20) YEARS; DETERMINING THAT, PURSUANT TO THE STATE ENVIRONMENTAL QUALITY REVIEW ACT ("SEQRA"), THE ACQUISITION OF SAID TRUCK IS A TYPE II ACTION AND DOES NOT REQUIRE ANY FURTHER REVIEW AND PROVIDING FOR THE LEVY OF TAXES TO BE COLLECTED TO PAY THE PRINCIPAL OF AND INTEREST ON SAID BONDS," BE APPROVED?

All residents of the Fire District who were duly registered to vote with the Ulster County Board of Elections on or before Monday, October 2, 2017, shall be eligible to vote at said Special Election.
